**ARTICLES OF INCORPORATION  
OF  
DEERWOOD EXPRESS, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation ("Corporation") is **DEERWOOD EXPRESS, INC.**

**ARTICLE II**

The existence of the corporation shall begin on the date these articles are filed with the Office of the Secretary of State.

**ARTICLE III**

The street address of the principal office of the Corporation is 863 Washburn Road, Melbourne, Florida 32934. The mailing address shall be the same.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 1000 shares, all of which shall be Common Shares. 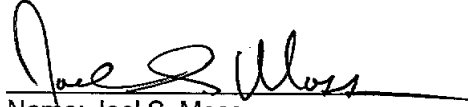
