Article I  
Identification

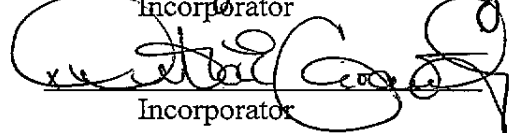
