ARTICLE I - NAME

The name of the corporation shall be T.L.M., INC.

ARTICLE II - CORPORATE EXISTENCE

The existence of this corporation shall commence on the 26th day of February, 2002; provided that if such day be unauthorized under the law, then on the earliest day allowable pursuant to the laws of the State of Florida for the commencement of corporate existence. The duration of the corporation shall be perpetual.

ARTICLE III - PURPOSE




