The undersigned incorporator hereby executes, acknowledges and files with the Florida Department of State the following Articles of Incorporation (the "Articles") for the purpose of organizing a corporation under the Florida Business Corporation Act (the "Act").

**ARTICLE I - Name**

The name of the corporation is HONDA JAPON AUTO PARTS, INC..

**ARTICLE II - Principal Office**

The initial principal place of business or mailing address of the Corporation shall be 608 Northeast 23<sup>rd</sup> Avenue, Apartment 1, Pompano Beach, Florida 33062.

**ARTICLE III - Term of Existence**

This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of the State of Florida within five days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

**ARTICLE IV - Nature of Business**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE V - Authorized Shares**

(a) Number. The Corporation is authorized to issue ten thousand (10,000) shares

of common stock having a par value of \$1.00 each.

- (b) Preemptive Rights. Shareholders shall have preemptive rights.






