ARTICLES OF INCORPORATION

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I
Name of Corporation

The name of the corporation shall be:

ARTICLE II Nature of Business

The general nature of the business to be transacted by this corporation is to invest in tax certificates and tax deeds and to perform and engage in any other activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE III Principal Place of Business
