**ARTICLES OF INCORPORATION  
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of this corporation is Pure Tap Water, Inc., and its purpose is to conduct any lawful business.

The existence of the corporation shall begin on the 1<sup>st</sup> of March 2002, and the existence of the corporation shall be perpetual.

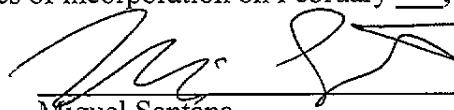

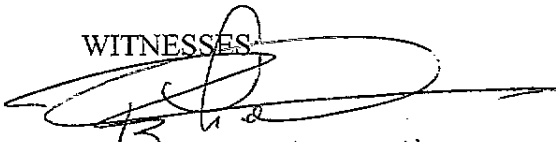

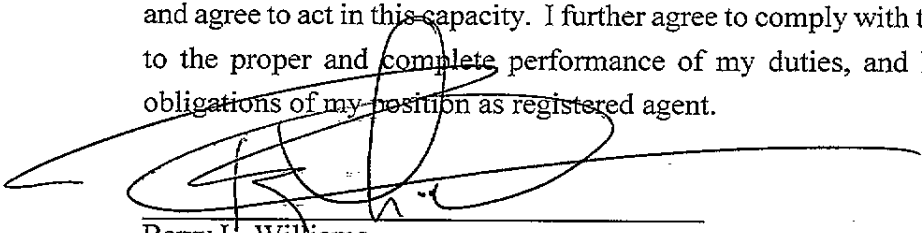
