ARTICLE I - NAME AND PRINCIPAL LOCATION

The name of this corporation is " I.T. Koeske, Inc." The principal location of the corporation is 1604 N. Halifax Avenue, Daytona Beach, Florida, 32118.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The general nature and purposes of the business to be transacted, promoted and carried on by the corporation are as follows: distribution and sale of medical imaging equipment, and engaging in any act, duties or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue Five Hundred (500) shares of common class, at One Dollar (\$1.00) par value.

ARTICLE X - INDEMNIFICATION

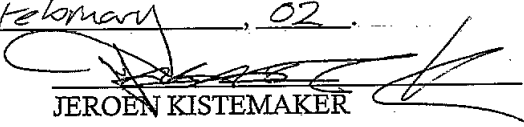
This corporation shall indemnify any officer or any former officer to the full extent permitted by Law.

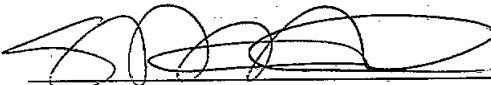

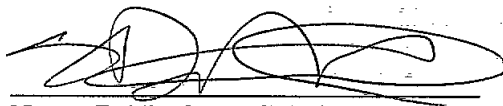
