THE NAME OF THE CORPORATION SHALL BE; T.M. & L.E. SINDT ENTERPRISES INC 1174 BASS BLVD. DINEDIN FL 34698.. WE THE UNDERSIGNED INCORPORATOR, BEING A NATURAL PERSON, HEREBY FILES THESE ARTICLES OF INCORPORATION TO FORM A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA.

ARTICLE I

A.
