# PHOTOS ON CANVAS, INC. (A Corporation for Profit)

The undersigned, desirous of forming a corporation, for profit, under the provisions of Ch. 607.0202(B) of the Florida Statutes, do agree to the following:

#### ARTICLE I. NAME

The name of the corporation is Photos on Canvas, Inc.

#### ARTICLE II. DURATION

This corporation shall have perpetual existence.

#### ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

#### ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 7500 shares of \$1.00 par value, common stock.

#### ARTICLE V. RESTRICTIONS ON STOCK
