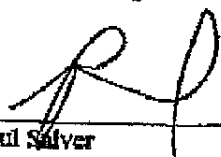

ARTICLE 10

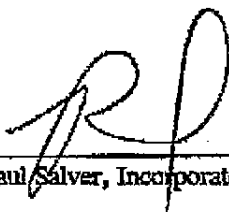
