<u>ARTICLES OF INCORPORATION</u>

OF

BOCA GOLD & CASINOS, INC.

The undersigned incorporator, for the purpose of forming a corporation (hereinafter referred to as the "Corporation") under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I: The name of the corporation shall be: Boca Gold & Casinos, Inc.

Article III: The number of shares of stock that the corporation is authorized to have outstanding at any one time is 1,000,000, all of which are of a par value of \$.01 dollars each and classified as Common shares.

Such indemnification provided shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, Agreement or Resolution adopted by the shareholders entitled to yote thereon after notice.
