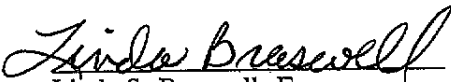

ARTICLE I - NAME

The name of this Corporation is DALMAR INTERNATIONAL, INC.

ARTICLE II - DURATION

This Corporation shall have a perpetual existence commencing on February 22, 2002.

ARTICLE III - PURPOSE

The Corporation may engage in any activity or business under the Laws of the United States and of the State of Florida, but specifically for the purpose of importation and exportation of goods or products.

ARTICLE IV - CAPITAL STOCK
