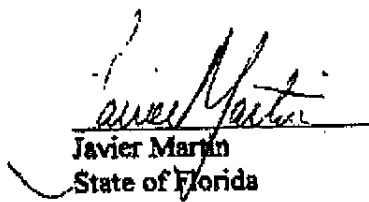
ARTICLE XV - AMENDMENT

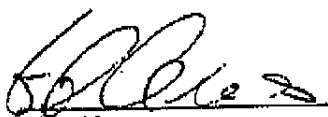
