ARTICLES OF INCORPORATION

OF

CARRIAGE PROPERTIES, INC.

The undersigned, acting as the incorporator of Carriage Properties, Inc., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation.

ARTICLE I - NAME

The name of this corporation is Carriage Properties, Inc.

ARTICLE II - ADDRESS

The principal office of the Corporation shall be:

ARTICLE III - CORPORATE EXISTENCE
