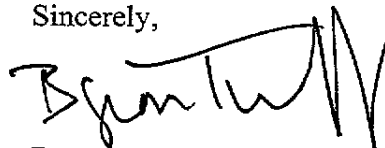

The undersigned, desiring to form a stock corporation under the provisions of Chapters 607 and 621 of the Florida Statutes, as amended, sets forth the following:

ARTICLE I

NAME

The name of the corporation shall be: Boca Raton Ambulatory Anesthesia Services, P.A.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business of the corporation shall be 40 N.E. 2nd Avenue, Deerfield, Florida 33441.

ARTICLE III

PURPOSES

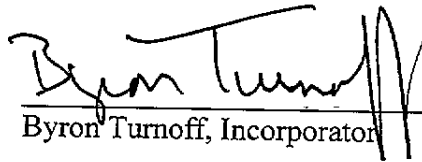

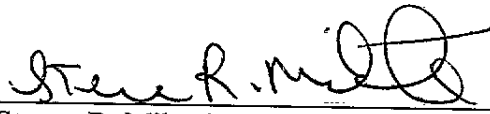
