RIGGS, being the holders of all the outstanding stock of all classes in an existing corporation known as "J F M ENERGY GROUP, INC.", whose Articles of Incorporation were previously filed with the Secretary of State of Florida on Feb. 26, 2002, being document #P02000023439, do hereby approve and consent to an increase in the authorized common stock of the corporation as set forth below. The number of votes cast for the Amendment by the shareholders is sufficient for approval of the Amendment. Such shareholders hereby execute this instrument for the purpose of signifying their approval and consent pursuant to Sections 607.1004(1)(a) and 607.1006(1) Florida Statutes of 2001.

Article IV of the Articles of Incorporation is amended to read:

" ARTICLE IV - CAPITAL STOCK:

The corporation is authorized to issue Ten million shares of One Dollar (\$1.00) par value common stock."

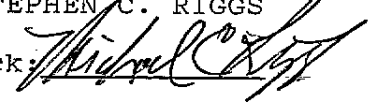

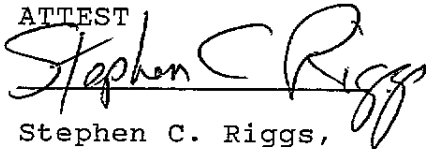
