"VILLANOVA CORPORATION"

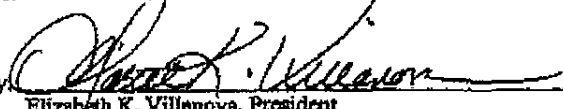
3. The amendment being effected hereby does not provide for an exchange, reclassification, or cancellation of issued shares.
