**ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

Article One

Name

The name of this Corporation shall be **RN Golf, Inc.**

Duration

The term of existence of this Corporation shall be perpetual.

The street address of the initial principal office of the Corporation shall be 1900 N.W. Corporate Boulevard, Suite 410 West, Boca Raton, FL 33431.


Article Six

This Corporation may have a maximum of three (3) directors. The number of directors may be changed from time to time by an amendment of the By-Laws of the Corporation.




