## ARTICLES OF INCORPORATION OF RN GOLF, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

## Article One

#### Name\_

#### Article Two

### **Duration**
