## ARTICLES OF INCORPORATION OF

### GSH Construction Co., Inc.

*The Undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

#### ARTICLE I - NAME

The name of the Corporation is: **GSH Construction Co., Inc.**

#### ARTICLE II - ADDRESS OF THE PRINCIPAL OFFICE

Located in **St. Johns County**, the principal place of business and street address of this corporation shall be: **664 Otter Court - Jacksonville, Florida 32259**

#### ARTICLE III - PURPOSE

The purpose of the corporation and the general nature of the business to be transacted shall be in construction and any other lawful business. 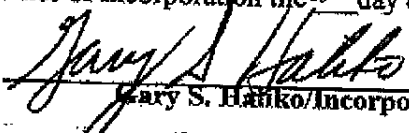
