ARTICLES OF INCORPORATION

OF

CBG FLORIDA REIT CORP.

The undersigned incorporator, pursuant to Sections 607.1005 and 607.1006 of the Florida Business Corporation Act, does hereby amend its Articles of Incorporation.

Article I

The name of the corporation is CBG Florida REIT Corp.

Article II

Article IV of the originally filed Articles of Incorporation shall be amended by replacing and substituting Article IV, Part A of the originally filed document with the following language:

The aggregate number of shares which the Corporation shall have the authority to issue shall be five thousand (5,000) shares of one class of common stock (the "Common Stock") with a par value of one cent (\$.01) per share and full voting rights and one thousand five hundred (1,500) shares of one class of preferred stock (the "Preferred Stock") with a par value of five hundred and no/100 Dollars (\$500.00) per share and no voting rights, except as otherwise expressly provided by law.

Article III

The amendment set forth above was adopted by the undersigned incorporator on April 25, 2002.

Article IV

The amendment set forth above was approved by the undersigned incorporator without shareholder action. Shareholder action is not required for approval of the amendment pursuant to Section 607.1005 of the Florida Business Corporation Act, because as of the date of the adoption of the amendment the Corporation has issued no shares of stock.

THE UNDERSIGNED, being the incorporator of the Corporation, for the purpose of amending the Articles of Incorporation of CBG Florida REIT Corp., filed on March 4, 2002, hereby declares and certifies that the facts herein stated are true, and accordingly has executed these Articles of Amendment this 25th day of April, 2002, pursuant to Sections 607.1005 and 607.1006 of the Florida Business Corporation Act.
