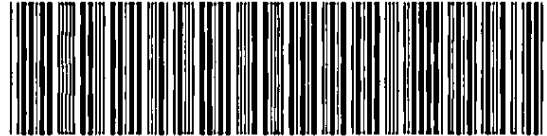

RESTATED ARTICLES OF INCORPORATION OF HINKLE & FORAN, P.A.  
WITH NAME CHANGE TO HINKLE LAW, P.A.

The Hinkle & Foran, P.A. articles of incorporation were filed March 4, 2002 with the State of Florida.

These restated articles consolidate all amendments into this single document.

The effective date is January 25, 2022.

The amendments were adopted by the incorporators and the Board of Directors with unanimous consent of all Shareholders.

This document is being filed pursuant to §607.0120, Fla. Stat.

The amendments were adopted by the incorporators and board of directors with unanimous consent of the shareholders.

The corporation hereby amends and restates the Articles of Incorporation to (1) change the name of the corporation to Hinkle Law, P.A.; (2) change the Articles of Incorporation to only require one director; and (3) designate Donald M. Hinkle as Registered Agent.

ARTICLE I: NAME. The name of the corporation is changed to Hinkle Law, P.A.

ARTICLE II: ADDRESS. The address of the corporation shall be 3520 Thomasville Road, Suite 501, Tallahassee, FL 32309

ARTICLE III: STOCK. The corporation's stock is currently owned by Donald M. Hinkle. The corporation is authorized to issue 100 shares of common stock. Each share is to have a par value of \$1.00.

ARTICLE IV: REGISTERED AGENT. The street address of the registered office for this corporation is: 3520 Thomasville Road, Suite 501, Tallahassee, FL 32309, and the registered agent is Donald M. Hinkle.

ARTICLE V: INCORPORATOR. The original incorporators were Donald M. Hinkle and Lisa Magill Foran, and the firm was incorporated as Hinkle & Foran, P.A. Lisa Magill Foran has conveyed all shares of stock to Donald M. Hinkle who is now the sole shareholder.

ARTICLE VI: DIRECTORS. The Board of Directors hereby amends and restates the Articles of Incorporation to (1) change the name of the corporation to Hinkle Law; (2) change the Articles of Incorporation to only require one director; and (3) designate the sole remaining shareholder, Donald M. Hinkle, as the only member of the Board of Directors.

The number of directors may increase or decrease from time to time in accordance with the laws of Florida. The affairs of the corporation shall be managed by the board of directors, who shall be elected by the shareholders.

ARTICLE VII: INDEMNIFICATION. The corporation shall indemnify any officer or director or any former officer or director to the full extent permitted by law.

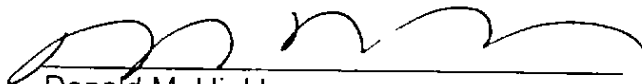
ARTICLE VIII: CORPORATE DURATION. The duration of the corporation shall be perpetual.

ARTICLE IX: PURPOSE OR PURPOSES. The corporation is organized for the following purposes:

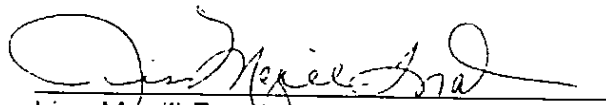
