ARTICLE I - NAME

The name of this corporation shall be: WORLD STONE AND TILE, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS



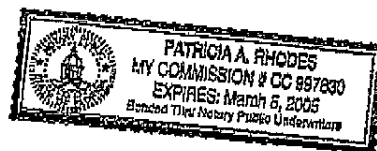


