The Corporation may elect to be an S Corporation, as provided in Sub-Chapter S of the Internal Revenue Code of 1986, as amended.

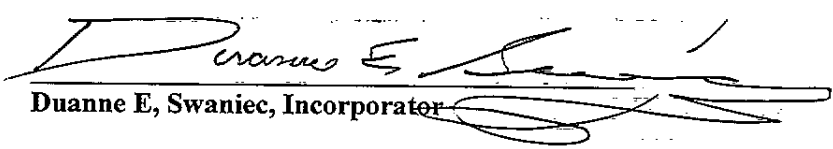
once the Corporation has elected to be an S Corporation, each share of stock issued by this Corporation shall contain the following legend:
