#### ARTICLES OF INCORPORATION

ARTICLE I - NAME :

The name of this corporation is:

GRECO-BRUNO HOMES, INC.

#### ARTICLE II - DURATION

This corporation is to exist perpetually and it shall commence its existence as of the date of subscription and acknowledgment, provided such date is within 5 days from the date of filling, otherwise, on the date of filing.
