ARTICLE I. NAME

The name of this corporation shall be FRYE GENERAL CONTRACTING OF WEST COAST FLORIDA, INC.

ARTICLE II. PRINCIPAL OFFICE

ARTICLE III. COMMENCEMENT & DURATION

This corporation shall indemnify any officer, director, employee, or agent, and any former officer, director, employee, or agent, to the full extent permitted by law.

ARTICLE VII. PREEMPTIVE RIGHTS

Each shareholder of the corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ration that the number of shares he holds at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares.
