ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida under the corporate name of JESSICA CORPORATION, does hereby set forth and declare:

CHARTER

ARTICLE I

Nothing herein contained shall create liability in the events above described or prevent the authorized approval of such contracts in any other manner permitted by law.
