**ARTICLES OF INCORPORATION**  
**OF**  
**R.A. PURVIS, INC.**

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles Of Incorporation.

**ARTICLE I - NAME**

The name of this Corporation is R.A. PURVIS, INC.

**ARTICLE II - NATURE OF BUSINESS**

The Corporation will provide Framing Contractor services and all services related to the construction industry to builders and to the Public.

**ARTICLE III - CAPITAL STOCK**

The authorized capital of the Corporation shall be 10,000 shares of common stock at a par value of \$1.00 per share.


