ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE I: NAME

The name of this corporation is INTERNATIONAL GOLD, DIAMOND AND GUN EXCHANGE, INC.

ARTICLE II: DURATION

The duration of the Corporation is perpetual.

ARTICLE III: NATURE OF BUSINESS

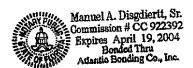
