

ARTICLE ONE

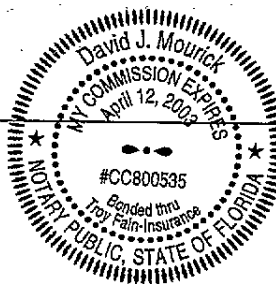
