ARTICLES OF INCORPORATION

OF

I, the undersigned, being of legal age and natural person, do hereby subscribe and acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the state of Florida.

ARTICLE I
NAME

The name of this corporation is IPC COMPUTERS, INC.
