I, the undersigned, being of legal age and natural person, do hereby subscribe E, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the state of Florida.

ARTICLE I

The name of this corporation is IPC COMPUTERS, INC.

ARTICLE II
PURPOSE
