


ARTICLE IX – BYLAWS




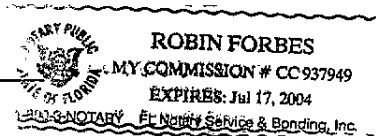
