Articles Of Incorporation

DoMar Broadcasting Company, Inc.

The undersigned, acting hereby as Incorporator for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit, pursuant to Chapter 607, Florida Statutes, and other applicable law, do hereby adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of this corporation shall be Do Mar Broadcasting Company, Inc., One Radio Road, St. Augustine, Florida 32084, 904-824-3416.

ARTICLE II DURATION

This corporation shall have a perpetual existence unless sooner dissolved according to law. Upon dissolution of the corporation all assets of the corporation, including real property and bank accounts, shall be given to: Douglas D. Shull, One Radio Road, St. Augustine, Florida 32095, 904-824-3416.

ARTICLE III PURPOSE

The purpose of this corporation is to have a radio broadcasting business under the Florida General Corporation Act.

AMENDMENTS

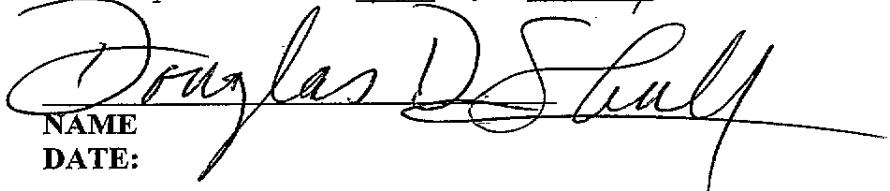
These Articles of Incorporation may be amended by the act of the Directors. Such amendments may be proposed and adopted in the manner provided in the By-Laws of the
