#### ARTICLE I - NAME

The name of this corporation is:

YAKAR, INC.

#### ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence on March 5, 2002.

#### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all business permitted under the laws of the United States of America and the laws of the State of Florida.

#### ARTICLE IV - CAPITAL STOCK
