ARTICLES OF INCORPORATION

OF

CLASSIC DRY CLEANERS AMERICA, INC.

The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The name of the corporation (hereinafter called the "Corporation") is Classic Dry Cleaners America, Inc.

SECOND: The principal office of the Corporation shall be located at 1301 Sawgrass Corporate Parkway, Sunrise, FL 33323. The mailing address of the Corporation is 1301 Sawgrass Corporate Parkway, Sunrise, FL 33323.

THIRD: The aggregate number of shares which the Corporation shall have authority to issue is 1,000, all of which are of a par value of \$0.01 each and are of the same class and are to be common shares.

<u>EIGHTH</u>: The existence of the Corporation shall begin on the date the undersigned incorporator has executed these Articles of Incorporation.
