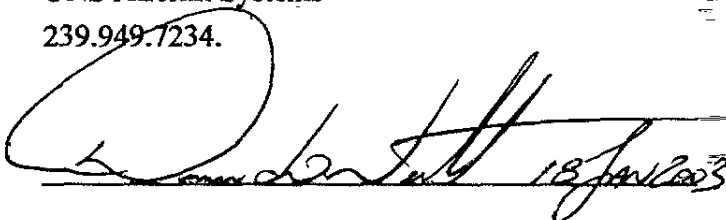
Articles of incorporation for ONS to operate as LLC have been filed with Florida State reference document number L03000001975.
