# **ARTICLES OF INCORPORATION**

The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

# **ARTICLES I: NAME OF THE CORPORATION**

The name of the corporation is **SUNSHINE COASTAL MEDICAL BILLING**, **INC**. hereinafter referred to as the "Corporation".

# ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS
