ARTICLE I. NAME AND ADDRESS

ARTICLE II. DURATION AND COMMENCEMENT

This corporation shall exist perpetually and shall commence on the date of execution and acknowledgment of these Articles of Incorporation.

ARTICLE III. PURPOSES

This corporation is organized for the following purposes:

- 1. To operate as a Chiropractic, health and wellness center for the health and benefit of the public.
