Article VIII – Directors

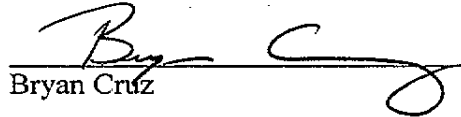

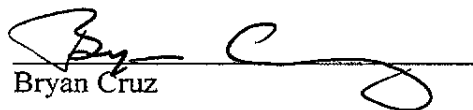
