## ARTICLES OF INCORPORATION OF GUARANTEE SERVICES INC.

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

#### ARTICLE ONE

NAME

The name of the corporation is Guarantee Services Inc.
