**ARTICLES OF INCORPORATION
OF
The Immokalee Professional Centre, P. A.**

The undersigned, licensed to practice social work in the state of Florida, desiring to form a professional association in accordance with Chapters 607 and 621 of the Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE I
NAME AND ADDRESS OF CORPORATION**

The name of this Corporation is The Immokalee Professional Centre, P. A. The initial address of the Corporation is 4501 Tamiami Trail North, Suite 300, Naples, Florida 34103.

**ARTICLE II
CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is ten thousand (10,000) shares of common stock. Such shares shall be treated as stock under Section 1244 of the Internal Revenue Code in the event of loss upon the sale or exchange of these shares. Any such loss shall be deemed an ordinary loss, to the extent allowed by Section 1244.

ARTICLE VI BY-LAWS

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors.

ARTICLE VII PURPOSES AND PROFESSIONAL SERVICES

The purpose for which the Corporation is to engage in the practice of social work within the State of Florida, and to take all actions that are necessary or proper in connection with that practice. The professional services of the Corporation shall be rendered only through officers, employees, and agents who are duly licensed or otherwise legally authorized to practice social work within the state of Florida. Professional services shall be rendered in each case by the officer, employee, or agent designated solely by this Corporation, acting through its duly elected officers. This provision shall not be applicable to the extent it is in conflict with the law or the professional rules of the practice of social work.

ARTICLE VIII INDEMNIFICATION

The Corporation shall indemnify any incorporator, officer or director, or any former officer or director, against all liability, expenses, costs, damages and attorneys' fees reasonably incurred for any action or inaction in connection with the Corporation except for gross negligence, willful misconduct, or criminal actions where the crime was not committed in a good faith or reasonable belief that the action was lawful and was not opposed to the best interests of the Corporation.

An officer or director shall not be liable to the Corporation for any loss or damage sustained by it for any action taken or omitted by him if he in good faith exercised the care of a prudent man, in good faith acted or failed to act based upon advice of counsel for the Corporation or on the books and records of the Corporation, or followed what he believed to be sound accounting and business practice.

The foregoing rights of indemnification are in addition to all other rights to which the officer or director may be entitled under law.
