ARTICLES OF INCORPORATION

ARTICLE I - NAME:

SECHETAL MASTATE TALLAHASSEE, FLORIDA

The name of this corporation is: HAL SMITH CO., hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE:
