**ARTICLES OF INCORPORATION  
OF**

**Dependable Executive Home Inspection, Inc.**

The undersigned natural person, acting hereby as Incorporator for the purposes of forming a corporation for profit under the provisions of the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I. CORPORATE NAME**

The name of the corporation is Dependable Executive Home Inspection, Inc.

**ARTICLE II. STREET ADDRESS OF INITIAL PRINCIPAL OFFICE**

**ARTICLE VIII. AMENDMENTS**


