**ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

Corporate Name. The name of this corporation is **SCOTT D. CAULEY, INC.** The initial mailing address of this corporation is **3377 Woodhill Dr., Tallahassee, FL 32303.**

ARTICLE II

Duration. The duration of this corporation is perpetual.

ARTICLE III

Purpose. The general purpose for which the corporation is organized are the following:

- a. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way; and
- b. To do such other necessary things as are incidental to the purpose of this corporation or necessary or desirable in order to accomplish that.

ARTICLE IV

Capital Stock. The aggregate number of shares of stock this corporation is authorized to issue and have outstanding at any one time is 1000 shares of common stock with the par value of \$0.01 per share.

ARTICLE V

Initial Registered Office and Registered Agent. The street address of the initial registered office of this corporation is **3377 Woodhil Dr., Tallahassee, FL 32303.** The name of the initial registered agent at this address is **SCOTT D. CAULEY.**

ARTICLE VI

Initial Board of Directors. The number of directors constituting the initial board of directors is two (2). The number of directors may be increased or decreased from time to time in accordance with the by-laws but shall never be less than one (1).
