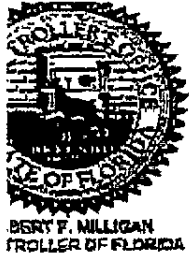



extent permitted by law.


ARTICLE X - AMENDMENT
