EDDIE PERALTA, the undersigned, being of the age of eighteen (18) years or more, does hereby make and acknowledge these Articles of Incorporation under and by virtue of the laws of the State of Florida.

1. The name of the Corporation shall be: MOBILESTAR COMMUNICATIONS, INC.
2. The number of shares the corporation is authorized to issue shall be 1000 shares all of one class designated as common stock, at \$ 1.00 per value.
3. The street address and county of the initial principal office of the corporation is 2866 NW 79th Ave. Miami, Fl. 33122 at Miami-Dade County, and the name of the initial registered agent at this address is Eddie Peralta.
4. The number of directors constituting the initial board of directors shall be three directors and the names and addresses of the persons who are to serve as directors until the first meeting of shareholders or until their successors are elected and qualify are:

No amendment shall be made to this Article when the number of shares voting against the proposal to amend would be sufficient to elect a director by cumulative voting and such shares are entitled to be voted cumulatively for the election of directors.
