ARTICLES OF INCORPORATION

SECRETARY OF STATE TALLAHASSEE FLORIDA

BOB TAYLOR, the undersigned, hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I - NAME
