The aggregate number of shares which the corporation shall have authority to issue is **100**, at \$1.00 par value.

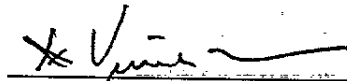
ARTICLE FIVE

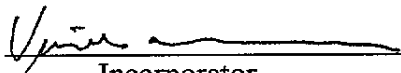
