**ARTICLES OF INCORPORATION
OF
VICTORIA A. WILLIAMS, INC.**

The undersigned Incorporator does hereby adopt the following Articles of Incorporation under Chapter 607 of the Florida Statutes, known as the Florida General Corporation Act:

**ARTICLE I
NAME AND ADDRESS**

The name of this corporation shall be VICTORIA A. WILLIAMS, INC. ("CORPORATION"). The street address, along with the mailing address of the principal office of the Corporation, shall be 8910 County Rd. 674, Bushnell, Fl. 33513

**ARTICLE II
TERM**

The corporation's existence shall commence upon the date of the filing of these Articles of Incorporation, and shall continue thereafter in perpetuity.

**ARTICLE III
PURPOSE**

The general purpose for which this corporation shall exist shall be to transact any or all lawful business permitted any corporation under the Florida General Corporation Act.

**ARTICLE IV
NUMBER OF AUTHORIZED SHARES**

H 02000051288

The corporation shall be authorized to issue an aggregate of One Thousand (1000) shares of common voting stock, each such share to have a par value of One Dollar (\$1.00) and all such shares being the same class.

**ARTICLE V
PREEMPTIVE RIGHTS**

All of the shareholders of this corporation shall be entitled to the benefits of preemptive rights with respect to any uninsured or treasury shares of ownership of this corporation.

RESIDENT AGENT**

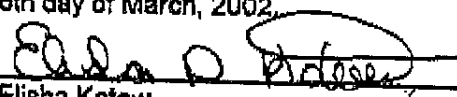
